### FEATURE OF THE MONTH

Placement - How Shares Get Routed from the OMS/EMS to the BIDS ATS

- BIDS believes that traders should have control over where they execute a cross. The BIDS ATS
  will only take a placement when you click the "firm-up" button on a BIDS invitation.
- Some ATSs may default your settings so that shares are locked up at the point of the initial match (i.e. before you take an action). This prevents you from choosing where you will cross.
- If you find your shares being locked up by another venue, speak with them about changing this setting. Only you should decide where you execute a trade.


